This has reference to your application in response to IBPS advertisement on IBPS's Website dated 22.07.2017 for the post of Officer Junior Management Grade-I and subsequently your selection for the said post in Maharashtra Gramin Bank through Common Written Test and Personal Interview. However, your appointment as an Officer Junior Management Grade-I is subject to terms & conditions mentioned herein Offer of Employment along with unconditional acceptance of this Offer of Employment by you on following terms & conditions -

1	You will be appointed as an Officer Junior Management Grade - I on probation with grade/pay (Rs. 23700 - 980/7 - 30560 - 1145/2 - 32850 - 1310/7 - 42020) w.e.f. date of joining at the Branch / Office of the Bank wherever you are posted.
2	You will draw a Basic Pay of Rs.23700/- (Rs. Twenty Three Thousand Seven Hundred only) every month along with Dearness Allowance, House Rent Allowance and other admissible allowances as per Service Rules & Regulations framed by the Bank from time to time.
3	You will be on probation for a period of two years from the date of your joining at Branch/Office of the Bank wherever you are posted.
4	You will be entitled with the first increment in the scale after completion of one year of satisfactory service from the date of your joining the Branch/Office of the Bank wherever you are posted. However, this would not amount to your confirmation in service as explained in Para - 6 below.
